## BBTS - Philippines

BBTS held another week of Modules in Quezon City, Philippines on Feb. 18-22, 2013, with Dr. Thomas M. Strouse teaching the Bible books of I and II Thessalonians and of Job to about 20 Filipino pastors and church workers. On Friday evening, Feb. 22, 2013, the host church Cornerstone Baptist Church held the first BBTS graduation service in Luzon with thirteen graduates. These thirteen with the ten graduates from Iloilo in 2011 give BBTS twenty-three Filipino alumni. Four of

the seminarians received their Master of Biblical Studies degree (L. Hitosis, P. Quising, M. Misterio, and L. Raquintan), and nine received their Certificate of Theology degree (D. Agbayani, P. Binas, M. Fernandez, R. Gustilo, E. Matig-A, F. Ragsac, R. Raquintan, L. Salgado, and Ira Tanierla). The Lord has enabled BBC to be involved with the training of national men and women for service in the respective assemblies.

Several of the graduates made the following comments about BBTS:

Pastor Perlito Binas, one-time imprisoned pastor beaten for his faith, stated, "One of the best decisions I made of recent years...to join Cornerstone Baptist Church extension classes...with BBTS...it enhanced the status of the church as an institution."

Pastor Marcelino Fernandez, recently baptized ex-Pentecostal minister, said "The knowledge learned helped me and the congregation because I am now able to impart godly truth in the right perspective." Pastor Florencio Ragsac testified, saying, "The first time I attended the BBTS classes, my faith in the Scripture began to be revived. This was so because that is the spirit of our teacher. Then my understanding and knowledge in God's word became more precise." Pastor

Leonardo Salgado said, the seminary "helped me to be equipped to become a more Biblical Christian and Pastor in heart, doctrine and in practice." MBS graduate, Pastor Lester Raquintan affirmed, saying, "I gained more confidence on the Word of God and I became more delighted to study it." Pastor Eric Matig-A declared, "I am thankful to God for giving me this great opportunity and as a pastor, I will preach and teach, and hold to things that I learned and I will remain in it. Pastor Ira Tanierla said, "I thank the Lord for Dr. Strouse who never gets tired in teaching pastors to be biblical!"

# The Bible's Practical Benefits

*"Blessed are the undefiled in the way, who walk in the law of the LORD. Blessed are they that keep his testimonies, and that seek him with the whole heart"*

The "law of the Lord" is the Word of God, "his testimonies." Given to us, that we should "walk in" them and should "seek him" with all our heart. King David shared with his son, Solomon, in the latter days of his life: *"And keep the charge of the LORD thy God, to walk in his ways, to keep his statutes, and his commandments, and his judgments, and his testimonies, as it is written in the law of Moses, that thou mayest prosper in all that thou doest, and whithersoever thou turnest thyself"* (1 Kings 2:3). The result of taking to heart God's Word is obedience. 

## Legislating Homeschooling?

Homeschooling has only been legal in each of the 50 states since 1996. Each state determines its own laws regarding homeschooling. To date Connecticut has enjoyed great freedoms in homeschooling. However, this year there are several proposals which may limit the freedoms we have in our homeschooling. Many of the proposed bills have to do with mental health, partially in response to the Newtown Tragedy.

Specifically proposed Bill 374 filed in the Connecticut General Assembly would require all homeschooled children ages 12, 14, and 17 to undergo a behavioral health assessment. These assessments would be conducted by an unspecified health care provider and would be conducted even though there was no indication whatsoever that these children had a behavioral problem See more at: <http://www.hsllda.org/hs/state/ct/201202040.asp>

There is a public hearing on Bill 374 March 8 at Wesleyan University in Middletown, CT. Please pray this bill and any other like it do not move beyond this stage.

On a National scale, there seems to be a change in the view of our own government toward the rights of homeschooling parents in general.

Home School Legal Defense Association (HSLDA) is actively involved in the case of a German homeschool family in the sixth circuit court of Appeals – the Federal

court, just below the Supreme Court. A partial summary of the case, written by Michael Farris, J.D., LL.M. HSLDA Founder and Chairman follows:

Uwe and Hannelore Romeike fled from Germany to the United States after their family was vigorously prosecuted (fines, forcible removal of their children, threats of jail and more) for homeschooling. Initially, the Romeikes were granted political asylum, but the U.S. government appealed that decision to the Board of Immigration Appeals. That Board sided with the government. HSLDA then appealed to the Sixth Circuit Court of Appeals—the federal court just below the Supreme Court.

The Romeikes' case is before the United States Court of Appeals for the Sixth Circuit. The case for the government is officially in the name of the Attorney General of the United States. The case is called *Romeike v. Holder*. Thus, the brief filed by the U.S. Department of Justice is filed on behalf of the attorney general himself—although we can be reasonably certain he has not personally read it. Nonetheless, it is a statement of the position of our government at a very high level.

We (HSLDA) argued that Germany is a party to many human rights treaties that contain specific provisions that protect the right of parents to provide an education that is different from the government schools. Parents have the explicit right to give their children an education according to their own philosophy.

While the United States government argued many things in their brief, there are three specific arguments that you should know about.

First, they argued that there was no violation of anyone's protected rights in a law that entirely

bans homeschooling. There would only be a problem if Germany banned homeschooling for some but permitted it for others.

Let's assess the position of the United States government on the face of its argument: a nation violates no one's rights if it bans homeschooling entirely.

There are two major portions of constitutional rights of citizens—fundamental liberties and equal protection. The U.S. Attorney General has said this about homeschooling. There is no fundamental liberty to homeschool. So long as a government bans homeschooling broadly and equally, there is no violation of your rights. This is a view which gives some acknowledgement to the principle of equal protection but which entirely jettisons the concept of fundamental liberties.

A second argument is revealing. The U.S. government contended that the Romeikes' case failed to show that there was any discrimination based on religion because, among other reasons, the Romeikes did not prove that all homeschoolers were religious, and that not all Christians believed they had to homeschool.

One final argument from Romeikes deserves our attention. One of the grounds for asylum is if persecution is aimed at a "particular social group." The definition of a "particular social group" requires a showing of an "immutable" characteristic that cannot change or should not be required to be changed. We contend that German homeschoolers are a particular social group who are being persecuted by their government. The U.S. government says that Germany's ban on homeschooling does not meet this standard because, of course, the family can change—they can simply stop homeschooling and let their children go to the public schools.

There are two main problems with this argument. First, our government does not understand that families like the Romeikes have two goals when they chose homeschooling. There are things they want to teach and there are things they want to avoid their children being taught in the government schools. This argument necessarily means that the United States government believes that it would not violate your rights if our own government banned homeschooling entirely. After all, you could teach your children your own values after they have had 22-26 hours of public school indoctrination aimed at counteracting religious and philosophical views the government doesn't like.

The second problem with this argument goes back to the definition of immutability. Immutable means a characteristic that cannot be changed or "should not be

required" to be changed. No one contends that homeschooling is a characteristic that cannot be changed. We simply contend that in a free nation it is a characteristic that should not be required to be changed.

When the United States government says that homeschooling is a mutable choice—they are saying that it is a characteristic that a government can legitimately coerce you to change. In other words, you have no protected right to choose the education for your children. Our nation could remove your ability to homeschool and your choice would be mutable—since the government has the authority to force you to implement their wishes.

We should understand that in these arguments by the U.S. government, something important is being said about our own liberties as American homeschoolers.

The Attorney General of the United States thinks that a law that bans homeschooling entirely violates no fundamental liberties.

Please continue to pray for our country.
